PRESIDENT'S MESSAGE BY JOSEPH JAKUBOWSKI, P.E., LEED AP

As part of my preparation and reflecting for this message, I realized two things: I've never really been president of anything (except my HOA because no one else wants to do it) and writing an interesting article without direction is difficult. Honestly, the last time I had this task was writing an essay for my application to the University of Delaware in 1997. That was the first step to my enjoyable and successful 20ish years in Delaware (with a quick hiatus in Massachusetts), and I'm hopeful that this will be the beginning of a productive time period for DAPE. I appreciate the opportunity that I've been given by DAPE to serve as the Council's Civil Engineering seat for the past few years, and I'm honored that my fellow Council members

have selected me as the Council President for 2020 - 2021.

Being an overthinking and procrastinating engineer, I researched messages from leaders of different organizations with the hope of inspiration. The majority discussed 2020, cancelled meetings and events, and the negative impact on operations. While I understand the importance and implications of the COVID-19 pandemic, social injustice, the U.S. Presidential Election, global wildfires, and the economic disruption, providing additional commentary will overshadow DAPE's recent accomplishments and ambitious plans for 2021. Led by our Executive Director Jen Wootten and her support staff along with the efforts of the Council and Committee members, 2020 has still been full of highlights. Although Jen's most recent newsletter message was titled "Business not quite as usual," I'd argue that this newsletter contains details of a productive year of service to our members.

If 2020 has taught us anything, we are resourceful and can adapt through new ways of thinking. However, we can all be limited by our experiences and knowledge, and teamwork by a diverse group will produce better results than a group of similar individuals. We need help in many different areas, and I am hopeful that this year DAPE's volunteers will come from a variety of backgrounds and will improve our demographics related to gender, ethnicity, race, age, and discipline. We appreciate any involvement of our members in their Association.

My participation with DAPE started with proctoring the Fundamentals of Engineering (FE) and Principles and Practice of Engineering (PE) exams, which is typically a half-day effort. I was convinced to run for a seat in the DAPE Council (unknowingly against a former DAPE Council President) that meets monthly and is the leadership group for DAPE. Although my election was unsuccessful, I volunteered with the Law Enforcement/Ethics Committee, which usually meets monthly for 1 to 2 hours and occasionally requires some independent work. Examining Committee has a similar time commitment, while other committees typically only meet quarterly. Other opportunities include helping with outreach and educational events, such as panel discussions, continuing education, and speaking with students about engineering.

Our website contains summaries of all of the committees, along with dates for the upcoming PE exams. Additionally, the majority of our meetings are open to the public. I encourage to you attend to see if it's a good fit. EXECUTIVE DIRECTOR'S MESSAGE BY JEN WOOTTEN

I keep a small sign on the windowsill of my DAPE office that reads "It's not written in stone." The message is etched into a brick - a funny visual reminder that I take to mean I should be open to change, but thoughtful about it.

The fact that I now work from my home office several days a week is a perfect example of the importance of being open to change. DAPE was able to react quickly back in March when it became clear that we'd have to change our daily routines significantly. We have been forced to examine why we have certain procedures in place, and make changes to remain as efficient as possible. I expect many of these changes will remain, even when it's back to business as usual. In a previously paper-heavy office environment, we've become experts at manipulating PDF files, saving some trees in the process. Our May 2020 Ethics webinar was attended by over 500 members (compared with 150 the prior year), since it was easier for our out-of-state members to attend. Our October 2020 PE exam administration was held at a new and improved location, and we recruited many new proctors to help.

Some challenges remain in the short-term. Legislative changes that were proposed this time last year are awaiting the 2021 reconvening of Delaware General Assembly. DAPE's planned website enhancements have been moving more slowly than I'd like. The cancellation of the April 2020 PE exam created a backlog of applicants that have met all of the other licensing requirements, but still need to pass the exam.

COVID has forced all of us to find silver linings where we can though. When the new website is ready to launch, DAPE will be able to provide online training for our members on how to log in and manage your account, and hopes to continue to expand our webinar training. A one-day regional PE exam has been planned for candidates in all Civil disciplines on January 26, 2021, to help with the backlog of examinees that were unable to test in October (while DAPE is not hosting this regional exam, our exam candidates will be permitted to register in other jurisdictions for this administration). Additionally, NCEES has accelerated the schedule for transitioning all PE exams to computer-based format by the end of 2021, so that most candidates will be able to take the exam year-round at their convenience.

With the cancellation of the April 2020 PE exam due to the pandemic, DAPE, along with NCEES member boards throughout the country, was faced with extra challenges in order to administer the October 2020 exam as safely as possible. NCEES MILESTONE – 100 YEAR ANNIVERSARY

The National Council of Examiners for Engineering and Surveying (NCEES) is a national nonprofit organization dedicated to advancing professional licensure for engineers and surveyors. NCEES develops, administers, and scores the examination used for engineering and surveying licensure in the U.S. and abroad. It also facilitates professional mobility and promotes uniformity of the U.S. licensure processes. The Delaware Association of Professional Engineers is a NCEES member, and part of the Northeast Zone. This year NCEES is celebrating its 100 year anniversary. Below are a few notable moments in NCEES history that were recognized in the most recent edition of "Licensure Exchange," NCEES's publication for licensure of engineers and surveyors.

- The first Council meeting was held on November 8, 1920 in Chicago and was attend by 10 state licensing boards.
- The current Council's members are 69 engineering and surveying licensing boards from all 50 states, the District of Columbia, Guam, Northern Mariana Islands, Puerto Rico, and the U.S. Virgin Islands.
- The first Fundamentals of Engineering (FE) exam was offered in Spring 1965.
- The Fundamentals of Surveying (FS) exam was first offered in Spring 1973.
- The initial Principles and Practice of Engineering (PE) exam was offered in Fall 1966, with separate exams for chemical, civil, electrical, and mechanical engineering.
- The Principles and Practice of Surveying (PS) exam was initially offered Spring 1974.
- Aeronautical/aerospace, ceramic, manufacturing, software and structural I/II (replaced with 16-hour structural) exams have all been offered and discontinued. Software engineering had the shortest run, beginning in spring 2013 and ending in spring 2019.
