# 2024 Distinguished Service Award: Charles McAllister, P.E.

Charlie earned a Bachelor's degree in Mechanical Engineering from the University of Delaware in 1970. A licensed PE since 1981, he worked in industry from 1970 until retiring in 2013, when he opened his own consulting firm. Charlie began his DAPE service as a member of the Law Enforcement & Ethics Committee in 2004. He was elected to DAPE's Council and served from 2006 through 2014 and again from 2015 to 2023. During his years with DAPE, Charlie has held every Executive Committee officer position (President, Vice President, Secretary, Treasurer and Immediate Past President).

Charlie chaired the Law Enforcement & Ethics (LEE) Committee for many years and continues to serve on both LEE and the Finance/Employee Benefits & Compensation Committee. He has also served on DAPE's External Affairs Committee and proctored many FE and PE exams in Delaware over the years. He has represented DAPE on the State of Delaware's Green Better Building Advisory Committee, and also served on New Castle County, Delaware's Licensing Inspection Review Board.

Charlie served on the NCEES Outreach Task Force in 2013/2014. Charlie (along with his wife Marlene) has attended countless NCEES Zone meetings and Annual meetings as a DAPE delegate, strengthening ties between Delaware and other Northeast Zone member boards. 

This fall, DAPE continued our effort to encourage senior engineering students at University of Delaware to register for the Fundamentals of Engineering exam. In addition to sponsoring and attending a welcome back event hosted by the College of Engineering early this semester, DAPE representatives were at UD for an "FE Exam Rally," helping students to register for the exam. We also made presentations to the Senior Design class and the student IEEE group. NCEES has increased outreach efforts as well, and now offers FE Exam Cords for graduates that have passed the FE. They also launched interactive practice exams for the FE.

DAPE encourages students and young professionals to reach out to our office if they have any questions about topics such as registering for the exam, decoupling the PE exam, tracking experience, creating an NCEES record, and becoming a Certified Engineer Intern. We also encourage them to sign up for this newsletter, to keep up on potential changes to licensure requirements, so please feel free to share this with your colleagues.

### 2024 Renewal Season &

Even-numbered years are the busiest at DAPE, since we have both PE renewals due June 30 followed quickly by Certificate of Authorization renewals due September 30. DAPE has made an effort in the last few years to minimize the number of "delinquent" licensees (those that don't renew in time), with postcard and multiple email reminders, along with encouraging licensees that have not met the renewal requirements to switch to inactive status until they do meet the requirements.

This year we started the PE renewal season with approximately 8,750 active PEs on our roster. On July 1, that number was down to 8,035. Today, it's back over 8,400. There are always some licensees that choose to let their Delaware PE lapse due to changes in employers and work opportunities, and our roster is also growing by about 50-60 new licensees each month.

We started the Certificate of Authorization (COA) renewal season with approximately 1,600 licensed firms. On October 1, we had 1,440 active COAs, and that number is close to 1,550 now (including about 30 new COAs that have been approved since the renewal window opened).

Since 2018, our roster of active licensees (PEs and COAs combined) has increased 20%, while average annual penalty fees have decreased 82%.

Now that the renewal season is over, this is a good time to remind licensees of two things:

1) Check the active rosters to be sure you and your firm are there (if the firm is offering or providing engineering to the public in Delaware):

2) Remember that we'll be conducting a random CPC audit in January 2025. Be sure your PDH Log form and documentation are organized, so that if you are selected, this will be a quick process.
